It is recommended that the applicator first conduct a trial under similar crop and environmental conditions to determine the optimum rate.

### DIRECTIONS FOR USE:

To prevent foam, the addition of an anti-foaming agent is suggested before DIMENSION is added to the spray water. Do not add any other surfactants to DIMENSION. Spray thoroughly, avoiding excess runoff of the spray solution. Rates: Use 2 to 12 ounces per acre in spray solution. Use the lower rates in applications where low water rates are used. Note: The above rates are considered to be adequate for most uses. Some herbicides may require higher rates for optimum uses. Follow the herbicide label directions when this occurs. However, do not add this product at a rate that exceeds 5% of the finished spray volume.
