GENERAL INFORMATION

NEW CENTURY EXTEND-97 is an improved spreader-sticker for use with insecticides, fungicides, acaracides and pesticides, wettable spray powders and sun protectant sprays. It is a complex adjuvant designed to improve coverage deposit and retention. NEW CENTURY EXTEND-97 improves the weatherability of spray deposits. It reduces losses due to light rain, dews and fog.

DIRECTIONS FOR USE

This product may be used in dilute or concentrate sprays. Add NEW CENTURY EXTEND-97 to spray tank first.

PER 100 GALLONS OF SPRAY MIX

Acaracides and Fungicides... 1/4 to 1 pint
Insecticides.....1/4 to 2 pints
Wettable Spray Powders.....1/4 - 1.5 pints
Sun Protectants.....2 pints
Lower rates should be used in high volume sprays.

Alkylaryl/polyoxyethylene glycol, glycol ethers, combined fatty acids, bis-(2-ethylhexyl) benzene dicarboxylate, isopropanol.97.6%
Inert ingredients: 2.4%
